### ADDITIONAL PAYMENTS AND FEES

1. All Annual payments add \$120.00 for utility charge for 30 amp services, \$180.00 for two 30 or one 50 amp services.
2. All Quarterly payments add \$30.00 for 30 amp and \$45.00 for two 30 or one 50 amp.
3. All Semi-Annual payments add \$60.00 for 30 amp and \$90 for two 30 or one 50 amp.
4. Dry storage is a separate fee. Non-slip holders \$150.00 per month. All annual slip holders that have four (4) jack stand vessels are \$110.00 per month and any vessel that requires more than four (4) jack stands, \$135 per month. All late payments will be penalized by the daily fee of \$1.25 per foot in addition to the payment schedule.
5. Trailer storage fees for slip holders shall be \$25.00 per month.
6. All live aboard renters will pay an additional \$1,500.00 per year, that will be automatically added to the current rate schedule. Persons staying on their vessel 4 or more days per week, on a regular basis, shall be subjected to live aboard fees.
7. All slip fees are for the listed annual, semi-annual or quarterly terms. There is not a pro-ration schedule if the slip is vacant anytime during the term of the contract.
