The marina hereby expressly disclaims all warranties either expressed or implied, including any implied warranty of merchantability or fitness for a particular purpose, and the marina neither assumes nor authorizes any person to agree to terms, notes, conditions, and prices as stated on front and back of this agreement by Garden State Yacht Sales.

It is the sole responsibility of the Lessee and or the boat owner to advise and instruct their captains, employees, guests and sub-contractors as to properly accessing our docks or boarding their boats.
