- Owner requests the Great Lakes Yacht Sales, Inc. to store owner's above described boat at Great Lakes Yacht Sales, Inc. storage facilities for the winter season beginning October 1, _____ and ending May 1, _____ at the rate posted at the time of this agreement. Please place boat in storage after October 1, _____.
- Owner agrees to accept re-delivery on May 1, _____ unless otherwise agreed in advance. If he fails to do so he is liable to a storage charge of \$5.00 for each day that remains in storage after said date.
- Storage charges are due in advance. A service charge of 1 1/2% will be charged after October 31.
- If owner fails to pay for any work, labor and materials supplied at owner's request, or if owner does not accept re-delivery of Boat on May 1, _____ Great Lakes Yacht Sales, Inc. shall have a lien on the Boat, motor and equipment, and may (but need not) sell the Boat, motor and equipment at public sale to the highest bidder for cash, and shall, after deducting from the proceeds of the sale all its charges and expenses of sale, including reasonable attorney's fee, render the overplus, if any, to owner.
- Lessee agrees to comply with all the regulations established by the Great Lakes Yacht Sales for storage of boats at Great Lakes Yacht Sales or its leased facilities.
- Neither Great Lakes Yacht Sales nor its agents shall be liable for damages to the Lessee, its agents, servants or guests, or any person claiming through Lessee, for injury to person or damages to a loss of property wherever located from any cause, or for damage exclusively, all claims arising from rain damage, unlocked boats, storms and vandalism.
- Lessee agrees to hold Great Lakes Yacht Sales harmless from any claims or liabilities arising out of any occurrences as a result of this agreement.
- No advertising signs or material, including for sale signs shall be placed on boats or property so as to be visible from shore or water without written permission of Great Lakes Yacht Sales.
- No outside contractor or labor for hire may be used on the premises of Great Lakes Yacht Sales, Inc.
- No work of any kind is to be done on any boat or motor stored at Great Lakes Yacht Sales without prior written approval.
- Owner to furnish a copy of proof of insurance to Great Lakes Yacht Sales.
- The engine manufacturers suggest and many require that the engines and generator be winterized on boats stored inside to avoid rust in the water passages. If Lessee chooses not to do so, the Lessee agrees that Great Lakes Yacht Sales is not responsible for any damage that may be caused.
