

MOTORCYCLE PARK RULES AND APPLICATION/USE AGREEMENT FOR MOTORCYCLE PARK AND FACILITIES

In consideration of being allowed to use the Motorcycle Park facilities indicated herein, the undersigned Responsible Person, individually, and also the below named Organization (if any, collectively herein "User") hereby agree as follows:

1. The User accepts, shall fully comply and ensure compliance with Harley-Davidson of Greensboro's regulations contained within this application form.
2. The User agrees to be present at all times throughout the permitted use time and have a copy of the approved permit available.
3. The User shall submit with this application a refundable security deposit of \$200.
4. The Motorcycle Park is inspected before and after the use time. Deposits will be returned upon compliance with the regulations herein and upon a satisfactory inspection. The security deposit will be returned by mail to the User the following week after the event.
5. The Person Responsible shall be directly responsible for any damage done or additional clean-up required as a result of the approved use. If an Organization is named below, the Person Responsible and the Organization shall be jointly and collectively responsible.
6. The User hereby agrees to indemnify, defend and save harmless Harley-Davidson of Greensboro, its agents, servants, employees, assigned and independent contractors of and from any alleged negligence with regard to personal injury, death, or property damage that may arise as a result of User's use of the Motorcycle Park facilities.
7. User acknowledges and agrees that Harley-Davidson of Greensboro employees or agents shall be allowed physical access to the Motorcycle Park at any time during the use period.
8. Issuance of this permit is exclusive to any other city or county permits which may be required.
9. Proof of liability insurance coverage for the event is required.
10. Park is open during Harley-Davidson of Greensboro's business hours; use beyond these times must be arranged by written permission from Harley-Davidson of Greensboro. Events must end by 5pm on Saturdays.
11. Applicant must be 21 years or older.
12. Alcohol beverages may not be brought onto the Motorcycle Park at any time. Alcoholic beverages may be purchased from "The Steel Horse Saloon" during operating hours.
13. Applicant may provide complimentary bottled water to participants at the event. All other beverages, including but limited to soft drinks, must be purchased at The Steel Horse Saloon.

14. We respectfully ask that the tables at The Steel Horse Saloon not be used as an extension of the seating in the park. The tables provided by The Steel Horse Saloon may be used by anyone purchasing beverages from the establishment. Please convey this request to all of your guests.
15. The User is responsible for hiring off-duty Greensboro Police Officers or Guilford County Sheriffs at the User's expense to provide security. The number of off-duty officers or sheriffs will be determined by Harley-Davidson of Greensboro and depend on the projected size of the event.

RULES FOR USE OF MOTORCYCLE PARK AND RETURN OF \$200 SECURITY DEPOSIT

1. Take down all decorations, staples, nails, tape, etc.
2. Sweep cement floors of stage.
3. All garbage and recyclable items must be placed in bags and REMOVED FROM THE PARK. Please bring your own trash container and for large groups, please bring extra bags.
4. No charcoal permitted, however gas grills are ok.
5. Note all problems that may have occurred previous to your reservation such as trash, garbage or damage. If you can, call the coordinator and leave a message with problems.
6. No vehicles of any kind on the grass and/or landscaping.
7. User/Applicant must be at the park facility during the entire use period and permit for use must be shown upon request.
8. CANCELLATION POLICY-Must cancel at least 2 weeks prior to event or deposit is lost.
9. The User is responsible for hiring off-duty Greensboro Police Officers or Guilford County Sheriffs at the User's expense to provide security. The number of off-duty officers or sheriffs will be determined by Harley-Davidson of Greensboro and depend on the projected size of the event.
10. Cannot attach anything to any structure in the park. This includes the stage, shade structures, or food vending area.
11. You are responsible for any excess damage to the grass and landscaping.
12. May not stake anything into the grass. For example, signage or dog tie-outs.
13. No racial slurs, slandering or swearing allowed on the property.
14. Treat the property as you would want someone to treat your home.
15. No glass bottles on park grounds.

FIRE REGULATIONS/CITY CODE: The user understands and agrees that any and all times when the Motorcycle Park facilities are in use, or otherwise occupied, all fire regulations as well as all other applicable city code and ordinances shall be enforced and strictly adhered to.

Without prior approval of Harley-Davidson of Greensboro, no open fires will be allowed. Caterers with insurance will be allowed cooking privileges. Evidence of insurance satisfactory to Harley-Davidson of Greensboro, shall accompany this Agreement.

FIREARMS: The possession and use of firearms is strictly prohibited, unless specifically approved in advance, and in writing, by the Greensboro Police Department and Harley-Davidson of Greensboro.

LIABILITY: Harley-Davidson of Greensboro shall not, in any event, be liable for any injury or damage to any property or person occurring on or near the Motorcycle Park premises, or for any injury or damage to the premises or to any property of the user or of any other person. The user hereby agrees to indemnify and hold Harley-Davidson of Greensboro harmless from and against any and all liabilities, losses, damages, suits, penalties, claims, and demands of every kind or nature, including reasonable counsel fees, by or on behalf of any person, party or governmental authority whatsoever, arising out of any incident, injury or damage that shall happen in, upon or about the Motorcycle Park premises during the period of use.

TERMINATION OF USE: The use of the premises specified above may be terminated by Harley-Davidson of Greensboro or the City of Greensboro if the user is found to be in violation of any of the terms and conditions of this Agreement. Upon such termination, all activities by the user will cease, all equipment, furnishing and other material will be removed from the Motorcycle Park forthwith, and the premises rendered back to the same condition as at the commencement of use.
