CATFISH TOURNAMENT RULES

Take Off/Weigh In: Hideaway Harbor

Located: Off Hwy. 94 North on Sioux Dr.

Date & Time: May 1, 2010 at 6:00am to 3:00pm

Entry Fee \$80.00 per team

(Ramp Late Fee Sign up \$20.00 CASH ONLY)

1. This is a team event. Team will consist of one or two persons. A third person may accompany the team provided the third person is under 16 years of age or over 65 years of age. **A four (4) rod limit applies.** (Meaning only 4 rods in the water at one time per team.) You may have unlimited rods in the boat with the team.
2. In case of extreme water/weather conditions the tournament director reserves the right to postpone or cancel these events with the return of all entry fees.
3. If paying by check or money order, you must sign-up by mail or phone **two (2) weeks** prior to each tournament. We will accept **cash only** for sign-ups on the day of the tournament.
4. Boats will leave launch site, by land or water. **(Trailer will be allowed.)** Boundaries are any waters accessible from weigh-in site.
5. Teams must compete from a boat & remain in the boat during competition. Fishing within 50 yards of the weigh-in site & 50 yards from a competitor's boat, which was first anchored, is prohibited.
6. All fish weighed must be caught by rod & reel only. No catfish may be taken from trot, jug or limb line.
7. Teams must comply with state fishing & boating regulations, including the use of P.F.D's & kill switches. Fishing and boating licenses are the responsibility of team members.
8. Fishing hours shall be 6am-3pm for day tournaments. All anglers must be in the weigh-in line by 4pm. **NO EXCEPTIONS!**
9. Any legal commercial or natural bait will be allowed. No chumming of any type during tournament hours. Fish must be a minimum of 15" in length to be weighed.
10. Blue, Channel, or Flathead catfish may be weighed in. A team limit of 5 maximum must be alive to be allowed to weigh-in. Only two fish over 34 inches can be included in the team limit.
11. Any protest must be made in writing to the tournament director within 30 minutes following the end of the official weigh-in. A protest must state the rule number(s) broken.
12. The use of alcoholic beverages is prohibited during the catfish tournament.
13. Wanton unsportsmanlike conduct can be grounds for disqualifications if circumstances require. Decision of tournament director will be **FINAL**.
14. All finalists will be subject to a polygraph test.
15. All boats will take off in the order in which entry fee is paid. A boat number will be assigned at the time of registration (when entry fee is paid). The boat number will also be the take off number for that boat.
